# **APARTMENT DESCRIPTION**

Liberty Lane is a new 80-unit apartment community for veterans and their families who are experiencing homelessness and living with a mental health disability, as well as for low-income households. Apartments for rent include 60 one-bedroom units and 19 two-bedroom units. One apartment is for the property manager. Seventeen (17) affordable apartment are now available for qualified households, with a veterans preference.

## **ABOUT THE PROPERTY**

Sixty-two (62) apartments are reserved for veterans experiencing homelessness and chronic homelessness, of which 55 apartments will include project-based rental subsidies (HUD-VASH) for homeless veterans eligible for supportive services from the U.S Department of Veteran Affairs (VA). The other seven (7) units will be for veterans that are not eligible for VASH or have regular Section 8 tenant-based vouchers.

The remaining 17 non-veteran restricted apartments will be conducted via lottery and are reserved for low-income individuals and families that make no more than 60% of the area median income (AMI).
